Freedom of Information Act 2000

I write further to your freedom of information request received on 11 March 2024. I note you seek access to the following information:

Between 14 May 2021 and the present day, I would like copies of all printed material distributed to households in the Leicester, Leicestershire, and Rutland area.

For the purpose of this request, "printed material" encompasses but is not limited to:

- Leaflets
- Pamphlets
- Brochures
- Posters
- Flyers
- Booklets

I would like to receive the information in a PNG or JPEG format.

Your request for information has now been considered and the response can be found below:

For the purposes of your request, we have interpreted *distributed to households in the Leicester, Leicestershire, and Rutland area* to be printed material which was sent to ALL households in Leicester, Leicestershire, and Rutland.

In September 2021, the Police and Crime Commissioner launched a consultation of the Police and Crime Plan. A leaflet which outlined the details of the consultation was distributed to all households across Leicester, Leicestershire, and Rutland. A copy of this leaflet has been attached.
