Your request for information has now been considered and the response can be found below:

1. The Name/Title/Scope of the commissioned programme in your area including programmes designed for male victims that accept/engage/support females –

The male DA Perpetrator Programme is delivered via FreeVa - The Jenkins Project, this project does not accept female perpetrators.

The OPCC Commissions Out of Court Resolutions (OOCR) for female DA Perpetrators these are delivered via New Dawn, New Day. The service provides support/interventions to female perpetrators of multiple crime types, not just DA.

2. The total number of females who self-referred into the programme

The OPCC does not hold this information as commissioned services are for females referred as part of an OOCR.

3. The total number of self-referred females who were accepted onto the programme.

5. The total number of females referred by an agency (e.g., police, social service etc.) into the programme

The provider delivers person centred approaches, as the females referred have been subject to an OOCR for a variety of crime types and as such delivery is not in the format of a 'programme'. Total number of referrals is 138, this covers all crime types, not just DA.

6. The total number of referred females who were accepted on to the programme

Total number accepted for interventions is 94, this covers all crime types, not just DA.

The total number of referred females who have completed the programme

Total number completing engagement with the provider is 91, this includes all crime types, not just DA. 2 referrals were continuing to engage with delivery at the end of 2022/23 but had not yet completed.
