Title: New Parks and Belgrave Police Stations

Summary of Issue:

The former Police Authority decided in May 2012 to release New Parks and Belgrave Police Stations for sale on the open market. However, the land on which the stations were constructed was acquired from Leicester City Council who imposed covenants on both sites. This effectively restricted their use to policing purposes only in the case of Belgrave and policing and community use for New Parks. Accordingly it was necessary to agree a release of these covenants with the Council in order that both properties could be used for any purpose and sold as such.

After lengthy negotiations with the Council, terms have been provisionally agreed for the release of the covenants. In respect of Belgrave, the Council will receive 8% of the capital sum received for the sale of the property and in respect of New Parks, the Council will receive 20% of the capital sum received. The difference in percentages reflects the difference in valuation terms with regard to the difficulty in developing the Belgrave site as opposed to the New Parks site as set out in the legal documentation when the sites were sold.

Since these terms were agreed, the Council have indicated that they would be interested in acquiring the New Parks Station. Accordingly, it has been further provisionally agreed that the Council can acquire the Station at market value with the benefit of a 20% reduction in such value. This, in effect, reflects the earlier agreement where we would have paid the Council 20% of the disposal figure on the open market. This arrangement is clearly subject to agreement between us and the Council as to the current open market value. In this connection the Council are currently undertaking their own valuation of the property. Our own property advisors have indicated that in their opinion the site should be placed on the open market at a figure of £250,000. Were the Council to agree to this figure, under the terms of the present agreement they would pay £200,000 for the property.

In terms of a replacement beat office for the Belgrave area, the Council have agreed that we can use a large office in the Belgrave Neighbourhood Centre on Belgrave Road for a period of five years for a capital sum of £10,000, which is the price we would normally pay for this type of beat office arrangement. At the end of the five year period we would either renegotiate terms for the accommodation at the Neighbourhood Centre or seek alternative space elsewhere. In respect of New

Parks, it will be necessary to seek a replacement beat office and this work is currently ongoing.

Recommendations presented:

It is recommended that the terms provisionally agreed as outlined above are approved.


