Title: Police and Crime Commissioners (PCC) Prevention Fund – Round 1
Successful Bids

Summary of Issue:

In his Commissioning Framework for 2017/18, the Police and Crime Commissioner set aside funding for a grants programme, named the Police and Crime Commissioner's Prevention Fund. The fund set aside is up to £250,000 for the year and the purpose is to support the achievement of the objectives within the Police and Crime Plan.

The Prevention Fund is a rolling grants programme throughout the year and bid applications will be considered by the PCC on a monthly basis.

For any funding bids where a second years funding is approved, the second year funding is provided in principle subject to effective delivery and performance in year one.

Grants awarded- Round 1

During Round 1, the PCC received 5 bid applications. All applications were assessed in line with the Prevention Fund Grant criteria and on the 28/6/17 all applications were presented to the PCC for final consideration and approval.

The PCC reviewed these applications together with the officers present and the Chief Finance Officer and Deputy Police and Crime Commissioner. At this meeting, officers felt that further information was required for two of the bids to enable the PCC to make a fully informed decision. This information was provided and the bid applications were discussed further on the 10/7/17 with the PCC by the officers stated above with the final decision made by the PCC.

At the meeting on the 10/7/17, the PCC approved the following Round 1 bids:

2017/18 £29,683.28 (3 bids)

2018/19 £9,956.42 (1 bid)

Remaining funding for the Prevention Fund in 2017/18 equates to £ 220,316.72.
