| Summary of Issue: Following the sale of the former Coalville Police Station in 2018 and our shared occupation of the Coalville Fire Station, the steady increase in staffing numbers has resulted in difficult working conditions in relation to the space available. Accordingly, consideration has been given to the acquisition of additional accommodation in Coalville in order to alleviate this problem. The attached options report sets out in some detail the outcome of these considerations together with recommendations which are set out below. In respect of option 5 in the report, if approved, it is intended to negotiate a break clause at both the end of the 5th year of the lease as well as the 10th year of the 15-year lease in order that the Force will have greater flexibility within the lease to relocate at either of those intervals should it be deemed necessary to do so. |
