Title: New Parks People Zone Funding Application

Summary of Issue:

The Police and Crime Commissioner for Leicestershire has allocated £30,000 from the Commissioning budget to fund projects/programmes or initiatives within the three current People Zone areas, the purpose of which is to support the achievements and objectives across all the People Zones areas. This includes investing in building community and providing interventions which will support parents, children and young people to achieve and make positive choices thereby creating a bedrock from which the community safety objectives of the PCC's Police and Crime Plan can be achieved in those specific communities.

The PCC has received and considered an application for projects in the New Parks People Zone area and has agreed to fund, as set out in Table 1. below.

Phoenix Judo Club		
GNR8 Boxing Scholarship Programme	To offer 20 young people who come from a low socio-economic backgrounds 10 months of free boxing. This includes 10 months' worth of training and their membership to the GNR8 Academy Gym.	6,000

The total sum approved for New Parks is £6,000. A number of other applications have already been approved (£19,948 has already been allocated) this therefore leaves a balance of £4,052.
