Title: Temporary Labour Contract award

Summary of Issue:

Leicestershire Police are looking to award a contract to Adecco for the supply of Temporary Labour for a period of 7 years from 3rd September 2022 to 2nd September 2029.

Background

Leicestershire Police currently have a contract with Brook Street for the provision of Temporary Labour that expires on 2nd September 2022. This current contract was let after a further competition under an ESPO Framework. The original contract period was from 1st October 2016 until 30th September 2020. However this has been extended until 2nd September 2022 due to Covid 19 and laterally to allow a new Bluelight Commercial National Framework to be available. During 2021/2022 financial year the Force spent £1.91m on Temporary Labour.

Tender Process

The tender process was managed by Bluelight Commercial on behalf of UK Police Forces.



The recommendation is to award the contract to Adecco for a 7 year period from 3rd September 2022 until 2nd September 2029 Total anticipated contract value is £13.13m.


