Title: CONT0189 Cloud Resources additional work

### Summary of Issue:

This is an extension to CONT0189 from 27<sup>th</sup> October 2023 to 26<sup>th</sup> October 2024. Risual have worked with us to assess services for migration to the cloud. This purchase will enable us to continue that effort, and undertake the recommended moves, by providing us with additional days of cloud consultancy and project support, not factored into at the time of the award.

This has been approved by the Assistant Chief Officer (Finance & Resources), OPCC Chief Finance Officer and the OPCC Interim CEO (reference SSD1027). I am requesting that the Police Commissioner signs the contract extension to Risual with an additional value of £147,600.00

### Background

This is an extension to contract CONT0189 Cloud Resource; as to change suppliers would incur significant internal cost, disruption and loss of know-how. We have built a strong working relationship with Risual and, having helped us develop it, their understanding of our cloud environment will help us make best use of it.

Procurement supports this purchase as a continuation of an existing contract for additional work, which would result in significant internal costs and disruption to the existing project if we were to change supplier and the new Cloud 13 framework rates have increased.

### Tender Process

This has been procured through a single source dispensation (SSD1027), approved by Assistant Chief Officer (Finance & Resources), OPCC Chief Finance Officer and the OPCC Interim CEO.

### Recommendation(s) presented:

I recommend that we award the Cloud Resources additional work to risual for a price of £147,600.00 and extend the current contract from 27<sup>th</sup> October 2023 for 1-year to 26<sup>th</sup> October 2024.
