Title: Safer Streets 5 Interventions

Summary of Issue:

In August 2023, the OPCC was given the opportunity to bid for funding from the Home Office as part of Safer Streets Round 5. There were 3 themes outlined that the Home Ofice wanted to see tackled for relevant areas which were VAWG (Violence against women and girls), Neighbourhood crime and ASB (Antisocial Behaviour). There was a 50% match funding element also required meaning for whatever we bid for, we had to find approximately 50% in match funding from within our own expenditure for the themes being applied for.

The delivery period for Safer Streets 5 was to be from October 2023 to March 2025 and therefore 18 months. The first grant given from the Home Office would cover the first 6 months which is October 2023 to the end of March 2024 (6 months). The second grant will cover April 2024 to March 2025 (12 months).

Upon applying, we were told we were successful in our bids although afterwards, we were told that year 2 would have a reduction of £180k in funding which required us to adjust our year 2 delivery plans.

For Oadby and Wigston the intended interventions with the reductions factored in are as follows.

This decision record is for the target hardening items we are looking to purchase from a supplier directly (video doorbells, CCTV cameras, window alarms, faraday pouches to protect keyless vehicles,

cocooning items) that were all outlined in the delivery plan submitted to the Home Office as part of our original bid. The original 18-month delivery plan at the time of the bid was to have up to 400 homes target hardened within Oadby and Wigston and 1300 homes delivered with cocooning items and up to 130 homes target hardened in Melton Mowbray.

Key discussion points

All aspects of the Safer Street 5 bid have been discussed in detail to reach this point. If we are not able to proceed with the necessary purchases, it is highly possible we will not be able to deliver on the target hardening (or other) elements of Safer Street 5.
