Title: Non Police Vehicle Disposal contract

Summary of Issue:

The current framework for non-Police vehicle disposal, with [Supplier Name withheld], expires 31st March 2024 and this covers Leicestershire, Nottinghamshire, Northamptonshire and Derbyshire Police Forces.

An open tender, advertised on Find a Tender Service (FTS) and Contracts Finder was published. The framework has been awarded to [Supplier Name withheld] Due to the estimated annual income of £616,860.00 for Leicestershire Police, with other Forces expected income is expected to be equivalent depending on their size and vehicles included. After deducting vehicle recovery and other costs, the approximately net income to all the Forces is 360,000 a year.

The framework. will need to be signed and sealed by Leicestershire Police & Crime Commissioner (as the Force leading the procurement), who will also sign the Leicestershire Police call off contract.

Background

The current non-Police vehicle disposal contract (CON786) with [Supplier Name withheld] expires 31st March 2024 and it was agreed that we go out to tender for the renewal. The framework covers Derbyshire, Leicestershire, Northamptonshire and Nottinghamshire.

Tender Process

An open tender was published on our Bluelight tendering portal and advertised on Find a Tender Service (FTS) and Contracts Finder. The weighting was net Income – 45% and Quality 55%. The framework was awarded to [Supplier Name withheld].

Recommendation(s) presented:

Procurement recommend that we award the Non-Police Vehicle Disposal opportunity to [Supplier Name withheld] for an estimated annual income of £616,860.00 for Leicestershire Police and approximately net income to all the Forces of £360,00 a year. Procurement also recommends that the Leicestershire Police & Crime Commissioner signs and seals the Leicestershire Police call off contract.
