Title: Appropriate Adults contract

Summary of Issue:

The current Appropriate Adults regional framework (covering Leicestershire, Northamptonshire, Nottinghamshire) framework and Leicestershire contract (CON886), with The Appropriate Adult Service (TAAS) expires 31st March. Leicestershire and Northamptonshire Police Forces decided to publish an open tender, advertised on Find A Tender and Contracts Finder. Nottinghamshire Police decided not to.

The tender has been awarded to TAAS for a four year framework with an option to have five year contracts. This has been approved by Assistant Chief Officer (Finance & Resources) and Procurement are requesting that the Police & Crime Commissioner signs and seals the framework and call off contract.

Background

The current Appropriate Adult contract with The Appropriate Adult Service (TAAS) expires 31st March 2024. The annual value is £150,000 for Leicestershire Police and £100,000 for Northamptonshire Police. The framework covered Leicestershire, Northamptonshire and Nottinghamshire Police Forces. However, Notts. Police decided not to be included in the new framework as they said that they weren't ready to finalise their requirements.

It was agreed to publish an open tender, advertised on FTS and Contracts Finder.

Tender Process

We received only one acceptable tender from TAAS.

Recommendation(s) presented:

I recommend that we award the Appropriate Adults Framework and Leicestershire Police call off contract to The Appropriate Adult Service (TAAS) for an estimated value of £1,000,000 (covering the four year framework and the optional five years contracts). The contract price, since the current framework rates set in 2019, has increased by les than 12%

Key discussion points

That the procurement complies with the Public Procurement regulations and is value for money.

The Police & Crime Commissioner signs the contract and adds his seal.
