Summary of Issue:

Leicestershire Police require the installation of ground solar panels at Headquarters. It was agreed to publish a further competition using SPO Renewables framework, Lot 1 Supply, Installation and maintenance of Solar PV systems and associated products.

The contract has been awarded to SDE Energy Solutions Ltd for a price of £325,537.33. Due to the value the contract requires the Police Commissioner to sign and add his seal.

Background

Estates require the supply and installation of HQ Ground Solar Panels, with T a 12-month defects liability period and 15 years insurance backed guarantees.

It was agreed to publish a further competition using ESPO Renewables framework, Lot 1 Supply, Installation and maintenance of Solar PV systems and associated products.

Tender Process

The companies on the framework were invited to tender and the tenders were evaluated Price 60% / Quality 40%. The tender was awarded to SDE Energy Solutions Ltd as the best value with the highest score. They also quoted the lowest compliant price.

Recommendation(s) presented:

I recommend that we award the HQ Solar Panel opportunity to SDE for a price of £325,537.33 and that the Police Commissioner signs the contract and adds his seal.
