Title: Commissioner's Safety Fund – Round 1 – 2024/2025

Decision summary:

In 2021/22 the Police and Crime Commissioner (PCC) launched his grant programme, The Commissioner's Safety Fund. Round 1 is the first general round of the 2024/2025 financial year.

Round 1 opened for applications on 8th August 2024 and closed on 5th September 2024. 88 applications were submitted during this time, with 1 application later being withdrawn, therefore leading to a total of 87 applications. The applications were assessed in line with the Commissioners Safety Fund criteria and moderated by a panel 16/09/2024 – 18/09/2024. Of the 87, 21 applications scored 71% or above, 11 scored between 65% - 70% and 55 scored less than 64%.

Due to the exceptional volume of applications and the quality of bids received, the decision was made to approve the recommendation on 25/09/2024 to award funding to those applications scoring 71% or higher. The decision was made that the PCC fund the following 21 projects. This equates to a funding commitment of £206,006.89.
