There are no views on disposal recorded from the assaulted officer as required.

In view of the fact that he had committed 2 previous offences within the preceding 14 months the panel felt the matter should have been referred to the Youth panel with a view to imposing some form of intervention. Additionally there was nothing recorded as to the youth's reasons for stealing food items, and as there was no end compliance date on the conditions of 'not to steal, and 'not to enter the specific shop' they were to all intents meaningless.

Observations made at the meeting which John will take forward:

- Victims views are not being recorded
- Good feedback to be given to office and their seniors
